### **GUIDELINES**

	1
Description of the Prize	The John Hirsch Prize was created in 1995 to recognize new and developing theatre directors who have demonstrated great potential for future excellence and exciting artistic vision. Two \$6,000 prizes are awarded every two years, one for each of the English-language and French-language theatre communities.  On his death in 1989, the distinguished theatre director John Hirsch left a bequest to the Canada Council to assist and encourage Canadian directors. The John Hirsch Prize is a tribute to the extraordinary contribution Mr. Hirsch made to theatre in Canada, most notably as founder of the Manitoba Theatre Centre, head of television drama for the CBC and artistic director of the Stratford Festival.
Eligibility	Nominees
g,	Nominees must have <b>no more than 10 years</b> of experience as a professional theatre director. They must also be Canadian citizens or have permanent resident status, as defined by Citizenship and Immigration Canada. They do not need to be living in Canada.
	They must also meet the Canada Council's definition of a professional artist, which is an artist who:
	<ul> <li>has specialized training in the field (not necessarily in academic institutions)</li> </ul>
	• is recognized as such by his or her peers (artists working in the same artistic tradition)
	<ul> <li>is committed to devoting more time to artistic activity, if possible financially</li> </ul>
	has a history of public presentation.
	Nominees must confirm their eligibility in the Declaration and in the curriculum vitae (as requested in Part B) <b>detailed chronologically</b> .
	An individual may receive this award only once in a lifetime.
	Nominators
	Nominators must also be Canadian citizens or have permanent resident status, as defined by Citizenship and Immigration Canada. They must be members of the Canadian professional theatre community.
Amount of the Prize	Two prizes of \$6,000 may be awarded in 2019-20, one for each of the English-language and French-language theatre communities.
Application/ Nomination Assistance	Funds are available to pay for services to individuals who experience disability-related barriers within the application/nomination or final reporting processes of Canada Council programs. Individuals who are Deaf, have disabilities or who are living with mental illness, may apply for funding to contribute to costs for services to assist them specifically in completing a prize application, a prize nomination or in submitting a final report.
	Please submit your request at least 4 weeks prior to a deadline. Contact the officer responsible for this prize by phone or e-mail. ## Nomination Process

Candidates may not apply for the prize. They must be nominated by an eligible nominator.

Nominators are responsible for gathering the required documentation and submitting it with the attached nomination form. They must ensure that the documents meet the requirements set out in these guidelines and the attached form.

## Assessment of Nominations

Peer evaluation is fundamental to the Canada Council's decision-making process. Eligible nominations will be evaluated by a peer assessment committee, composed of experienced theatre professionals who are selected for their expertise. Committee members will also be selected with consideration to fair representation of artistic specializations, gender, generations, Indigenous peoples, and the cultural and regional diversity of Canada.

An English-language committee assesses nominations submitted by the English-language theatre community, and a French-language committee assesses nominations submitted by the French-language theatre community.

The peer assessment committee may decide not to award one or both of the prizes in a given year.

All peer assessment committee recommendations are final.

#### Assessment criteria

The peer assessment committee will assess the nominations on the basis of each candidate's artistic vision and demonstrated potential for future excellence as a theatre director.

### **IMPORTANT INFORMATION**

## Processing the Nomination

### Nomination preparation

- The nominator is responsible for providing all the information and support material requested.
- The Canada Council will make decisions about eligibility based on the information provided in the nomination.
- Submit only the material requested. Extra material will not be shown to the peer assessment committee.
- Carefully choose the material to submit as committee members have limited time in which to study each nomination.
- It is important to inform the Canada Council of any changes to contact information. Nominators and nominees that have an account in the Canada Council's portal must update changes directly through their account.
- See the nomination form for instructions on how to submit your nomination and support material.
- The declaration pages for the nominator and the nominee **must be** submitted on paper with an original signature in ink.

### Response time

The winners of the prizes will be notified, by telephone, approximately **four** months after the deadline date.

The nominators of non-winning nominees will be notified of the results, by letter, shortly before the public announcement of the winners (which may take place later than 4 months after the nomination deadline).

Except for the notification of the winners, results will not be released over the telephone or by email.

### Curriculum vitae of nominee

Submit a current professional curriculum vitae for the nominee, **detailed chronologically**, with emphasis on their artistic achievements in theatre.

The curriculum vitae must include a short statement from the nominee indicating when and in what capacity the nominee would define the beginning of their experience as a professional theatre director (no more than 10 years before the date of this nomination).

### Artistic statement of the nominee

Provide a statement outlining your personal artistic goals, clearly explaining what you believe is necessary for you to achieve your potential as a theatre director (maximum 1,500 words). Please be as specific as you can about the path of development you would like to pursue in the future. Be sure to sign your statement; a signature is required.

### Letter of support

Please provide one signed letter of support from another Canadian theatre professional (maximum **1,500 words**). **A signature is required**.

### Instructions for submitting written documents

- Written documents may be submitted on a USB key, CD, DVD or in paper format.
- Text files submitted on a USB key, CD, DVD must be in .pdf, .doc or .docx, .txt or .rtf format.
- Do not use punctuation, spaces, special characters, or more than 45 characters in your file names.
- Avoid unusual formatting as it can make documents hard to read.

### All paper documents must be:

- printed on one side only
- on separate sheets of white paper (letter format, 8½ x 11 inches)
- with a black font size of 11 points or larger
- with paper clips (documents cannot be bound, placed under plastic or stapled).

### Digital support material

### Instructions for submitting digital support material

- You must submit digital support material on USB key, CD or DVD.
- Do not use punctuation, spaces, special characters, or more than 45 characters in file names.
- Internet links must go directly to your support material and should not require further navigation or a file to be downloaded. URLs must be accessible throughout the assessment process. The Canada Council takes no responsibility for links that do not work.
- Test the material before you submit it to ensure that it is formatted correctly. It is your responsibility to ensure that all material reaches the Canada Council intact and in a readable format.
- The total combined size of all files you submit cannot exceed 4GB.
